CoolSavings terms and conditions

1. CoolSavings is a free program available to qualifying **small commercial** customers for cooling units served on our Small General Service or General Service Rate.
2. You must enroll in CoolSavings for a minimum of one year from the date we install control equipment at your business.
3. We'll install, inspect, test, and maintain a radio receiver to control your air conditioning without charge. You must allow reasonable access to the radio receiver and any other company-owned equipment.
4. Enrollment continues automatically year to year until we receive notification of cancellation. After participating for a full year, you may cancel by calling 800-493-3299.
5. You must allow us to control all central cooling equipment at the location of service.
6. Maximum cycled control won't exceed 8 hours a day or 300 hours during the summer season, which is June through September.
7. We aren't liable for any loss, cost, damage, or injury resulting from interruptions or restorations of service that may occur while you're participating in CoolSavings.
8. If you tamper with any load-management equipment located on your property, we may discontinue your participation in CoolSavings and bill you for expenses to remove company equipment plus investigative charges.
9. We reserve the right to deny participation or cancel enrollment in CoolSavings at any time. Reasons for denial or cancellation include, but aren't limited to, excessive installation costs, oversized or undersized air-conditioning equipment, or abnormal utilization of equipment, including seasonal homes and other limited-use situations.
10. CoolSavings participants receive a credit of \$6/ton of cooling capacity per month for participating June through September. Credit applied may be prorated and may change by action of applicable state regulatory bodies.

- During occasional peak periods we'll cycle your single stage systems on a 15-minute on/15-minute off schedule. Dual stage systems may have the first stage run without interruption while the second stage is shut off during the entire control event. Either way, you'll stay cool!
- In the last five years customers on CoolSavings on average have experienced about 80 hours of cycled control each summer.
